- A. Restaurant Erin Shanks We had a very good month.
- **B. Pro Shop** Nate Benedict The pool was opened last Tuesday. There is a pump that is not working and another that is very old. Nate recommends replacing them. The cost is approximately \$2500 each. Nate would like to use some of the debt service account to replace those pumps. It will be done in two separate months. Five new lifeguards, 20 in total. Pool will open on the 23rd. The rough mower is down. Nate is looking into seeing if it can be fixed but it will be about 5 weeks before they can look at it. The pod mower can't get between the trees. A new mower will cost approximately \$135,000. Nate has reached out to Toro to see how much it will cost to lease. Could it be tied into a lease with an aerator? Marcus was wondering if we should set up a budget for a used mower. We could either get a loan or add to the line of credit. The rough mower is an immediate issue. Nate and Marcus will continue gathering information. The sander is up and running.
